- (ii) Noted that the HP-Private Educational Institutions Regulatory Commission, Shimla has vide its letter No. HP-PERC/CA/MMU/2016-17-2737 dated 10-3-2016 allowed the course of M.Sc. Chemistry to be continued for the session 2016-17 with an intake of 30 seats.
